- *All applicable fees (such as, mandatory fees, housing maintenance fee, student assessment fee, lab fees, etc.) are not covered by this award.*
- *Dillard University reserves the right to replace this award with other sources in the same amount in order to use limited resources to support the needs of all students.*
- *The scholarship award policy of the University is to assist students with the direct costs of their education, and to provide access to higher education costs of a private college education. The scholarship program is not designed or intended for students to make a financial profit.*
